**AND**

**WHEREAS**, Non-profit Organizations (NPOs) can register in NGO Darpan Portal to obtain a **UNIQUE INDENTITY NUMBER** who are seeking grants from the Ministries/Departments of Government of India;

**AND**

**WHEREAS**, as per the prevention of money laundering (maintenance of Records) Amendment Rules, 2023 all financial institution have been mandated to ensure NGO Darpan Unique ID for opening and operating accounts in any Bank;

**AND**

**WHEREAS**, the NGO Darpan Unique ID is required for registration/renewal of FCRA and also seeking exemptions under Section 80-G of Income tax Act;

**NOW**, the Registrar of Societies, Government of Tripura is hereby requested all the Non-Government Organization (NGOs)/Non-Profit Organizations (NPOs) registered under Societies Registration Act, 1860 in Tripura to obtain **UNIQUE INDENTITY NUMBER** by using NGO Darpan Portal maintained by NITI Aayog, Government of India as the Darpan Unique ID is now essential for all NGOs/NPOs to be able to carry out their activities through the banking system.
