Minimum 15 years Administrative & Academic experience in senior executive capacity or Head of the Institutions in recognised University/Institute/Cooperative Training Organisation/Cooperative Institute/Cooperative Department/Govt. Organizations/Semi-Govt./PSUs/Autonomous Body and

- (i) holding analogous post on regular basis in parent cadre or Department or
  - (ii) with three regular service in the scale of pay of Rs. 37,400-Rs. 67,000 with Grade Pay of Rs. 8700 in PB-4 (Pre-revised) or equivalent in parent cadre or Department.
3. The deputation with NCCT/VAMNICOM will be on Foreign Service terms and conditions.
4. The period of deputation (including short term contract) period of deputation in another ex-cadre post held immediately preceding this appointment, in the same or some other Organization/Department of the GOI shall ordinarily not exceed three years.
5. Officer selected will have the option to draw his pay plus deputation(duty) allowance or to have his pay fixed in the pay matrix of the post in accordance with the Department of Personnel & Training O.M. No. 6/8/2009-Estt.(Pay-II) dated 17-06-2010, as amended from time to time.
