MEMORANDUM

The Ministry of Culture, Government of India has issued instruction to all the State Government/Union Territories for rendering of the National Anthem in the portal created by the Government of India in connection with Azadi Ka Amrit Mahotsav and upload the National Anthem by each and every citizen of the State including all dignitaries, official before 15th August, 2021. The procedure to contribute rendering of National Anthem at given portal <u>https://rashtragaan.in/</u> is given below:

Step 1: Enter your details. **Step 2**: Stand and Record National Anthem. **Step 3**: Upload (Before 15th August, 2021). **Step 4**: Download Certificate.

Accordingly, it has been decided by the Government to contribute rendering of National Anthem at a time throughout the State by all the official at the State level, District level, Sub-Divisional level, Block level including public representative, citizen to render the National Anthem and upload the same according to the procedure as given above. The specific date and time for rendering of the National Anthem by all concerned Department, Dignitaries etc is given below:

Date and time to contribute rendering of National Anthem- 11th August, 2021 at 11.00 AM.

Therefore, all the State Government Department/PSUs etc will issue specific instruction to all concerned officials to take part in the festive mode programme of uploading of National Anthem. However, specific instruction as desired by the Government for participation and mass involvement of the employees and others with advance publicity by the Head of Department, District Magistrate & Collectors, Sub-Divisional level authority, Block, AMC, NP level authority etc are mentioned below:

- A. **State Level**: All Principal Secretaries/Secretaries as well as all Officers and official of Secretariat. All Head of the Department along with the others officials of the concerned Department in State level. All PSUs and Boards in State level.
- B. District Level: DM & Collector of concerned District along with others officers and officials. All Head of office and officials of the concerned District Offices. PRI bodies in District levels.
- C. Sub-Division Level: Sub-Divisional Magistrate of respective Sub-Divisions along with other officers and officials, All Head of office and officials of the concerned Sub-Division offices.
- D. Block/MC/NP Level: All BDOs in Block level along with other officials, All CEO/EO in MC and NP level along with others officials. PRI bodies may also be involved. Special initiates may be taken in Block/MC/NP level to take active participation of common people/youth and women.
- E. **Panchayat/Village Level**: All Panchayat/VC may be taken special initiates in jurisdiction to take active participation of common people/youth and women.
